Terms and Conditions:

- Sourced from BPI Accredited Nursery with BPI materials certificate for each variety
- Planted in at least 6 x 10 x 0.003 inches, black polyethylene bag
- At least 60 cm in height but not more than 100 cm from the soil line
- Grafted bud union must be 20 – 30 cm from the soil line and fully healed with no plastic
- At least 4 matured leaves from the bud union
- Supplier must provide 5% mortality allowance

Delivery of the Goods is required **within 60 calendar days from receipt of Notice to Proceed and to be delivered at the attached delivery sites.**

Bidders should have completed, within three (3) years (**2021-present**) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The prospective Bidder must be registered in the PhilGEPS.

In lieu of a bid security, the bidder may submit a duly notarized **Bid Securing Declaration** that is an undertaking which states, among others, that the bidder shall enter into contract with the procuring entity and furnish the required performance security within 10 calendar days from receipt of the notice of award, and committing to pay the corresponding fine and be suspended for a period of time from being qualified to participate in any government procurement activity in the event that it violates any of the conditions stated therein as required in the guidelines issued by the GPPB.

9. Bid opening shall be at **9:30 a.m.** on **March 20, 2024** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Department of Agriculture-Western Visayas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
