 (Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the Procurement of Supply and Delivery of Various Farm Tools in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 3,670,517.00;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their application for eligibility and bid offer;

WHEREAS, the two (2) bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposal of the two (2) bidders were found to be substantially complying:


NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;
