

RESOLUTION NO. 0481

WHEREAS, the agency has an original project, Procurement of Supply and Delivery of Five (5) Units Corn Sheller with an Approved Budget for the Contract (ABC) of One Million Three Hundred Fifty Thousand Pesos (Php 1,350,000.00);

WHEREAS, the Bids and Awards Committee (BAC) for Agri-Infra, Farm Machineries and Vehicles (AMV) has issued a Resolution No. 2024-043 dated February 14, 2024 recommending the award of contract to Agricom Visayas, Inc. in the amount of One Million One Hundred Forty-Four Thousand Pesos (Php 1,144,000.00);

WHEREAS, the BAC Resolution was approved by the Head of the Procuring Entity and a Notice to Proceed was issued and received by Agricom Visayas, Inc. on May 6, 2024;

WHEREAS, five (5) units corn sheller were delivered on May 10, 2024;

WHEREAS, a Purchase Request (PR) for the Procurement of Supply and Delivery of 1 unit Corn Sheller with an ABC of Two Hundred Twenty-Eight Thousand Eight Hundred Pesos (Php 228,800.00) was made;


WHEREAS, under Section 51, Article XVI of R.A. 9184 and its Revised Implementing Rules and Regulations and when provided for in the Annual Procurement Plan, REPEAT ORDER as an Alternative Method of Procurement may be allowed wherein the Procuring Entity directly procure MACHINERIES from the previously contracted winning bidder under the following conditions;


- a. The unit price offered by Agricom Visayas, Inc. under Repeat Order is equal to or lower than that provided in the original contract;
- b. The repeat order does not result in splitting of requisitions or purchase orders;
- c. The repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the original contract wherein partial delivery, inspection and acceptance of the goods was already made; and
- d. The repeat order does not exceed twenty-five percent (25%) of the quantity of each item of the original contract.

THEREFORE, the Bids and Awards Committee for Goods and Services RESOLVE as it is hereby RESOLVED that REPEAT ORDER shall be the mode of procurement in favor of Agricom Visayas, Inc. for the Procurement of Supply and Delivery of 1 unit Corn Sheller.


