

RESOLUTION NO. SDA

WHEREAS, the agency has an original project, Procurement of Supply and Delivery of Twelve (12) Units Pump and Engine Set (PISOS) with an Approved Budget for the Contract (ABC) of One Million Two Hundred Sixty Thousand Pesos (Php 1,260,000.00);

WHEREAS, the Bids and Awards Committee (BAC) for Agri-Infra, Farm Machineries and Vehicles (AMV) has issued a Resolution No. 2024-014 dated January 17, 2024 recommending the award of contract to ALL CERTIFIED EQUIPMENT TRADING CORPORATION in the amount of One Million One Hundred Forty Thousand Pesos (Php 1,140,000.00);

WHEREAS, the BAC Resolution was approved by the Head of the Procuring Entity and a Notice to Proceed was issued and received by ALL CERTIFIED EQUIPMENT TRADING CORPORATION on February 22, 2024;

WHEREAS, Twelve (12) Units Pump and Engine Set (PISOS) were delivered on March 13, 2024;

WHEREAS, a Purchase Request (PR) for the Procurement of Supply and Delivery of 1 Unit Pump and Engine Set (PISOS) with an ABC of Ninety-Five Thousand Pesos (Php 95,000.00) was made to utilize the savings out of One Million Two Hundred Sixty Thousand Pesos (Php 1,260,000.00);

WHEREAS, under Section 51, Article XVI of R.A. 9184 and its Revised Implementing Rules and Regulations and when provided for in the Annual Procurement Plan, REPEAT ORDER as an Alternative Method of Procurement may be allowed wherein the Procuring Entity directly procure MACHINERIES from the previously contracted winning bidder under the following conditions;

- a. The unit price offered by ALL CERTIFIED EQUIPMENT TRADING CORPORATION under Repeat Order is equal to or lower than that provided in the original contract;
- b. The repeat order does not result in splitting of requisitions or purchase orders;
- c. The repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the original contract wherein partial delivery, inspection and acceptance of the goods was already made; and
- d. The repeat order does not exceed twenty-five percent (25%) of the quantity of each item of the original contract.

THEREFORE, the Bids and Awards Committee for Agri-Infra, Farm Machineries and Vehicles RESOLVE as it is hereby RESOLVED that REPEAT ORDER shall be the mode of procurement in favor of ALL CERTIFIED EQUIPMENT TRADING CORPORATION for the Procurement of Supply and Delivery of 1 Unit Pump and Engine Set (PISOS).


