

BAC Resolution No. 019, Series of 2024

Procurement of Supply and Delivery of Split Type Aircon with Full Installation

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Split Type Aircon with Full Installation** with an Approved Budget for the Contract (ABC) of **One Hundred Forty-Six Thousand Pesos Only (Php 146,000.00)**.

WHEREAS, on Mar. 26, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **JUANTONG & SONS BUILDER CORPORATION**; (2) **VIC IMPERIAL APPLIANCE CORPORATION**; (3) **NIG MARKETING CORPORATION**; (4) **EMCOR INC.**; (5) **TOPMOST DEV'T AND MKTG. CORP.**

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on Apr. 2, 2024, **JUANTONG & SONS BUILDER CORPORATION**, **VIC IMPERIAL APPLIANCE CORPORATION**, **NIG MARKETING CORPORATION**, **EMCOR INC.** and **TOPMOST DEV'T AND MKTG. CORP.** submitted their quotations.

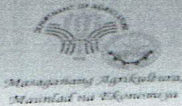
WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **VIC IMPERIAL APPLIANCE CORPORATION** is considered as the lowest offeror. However, upon receipt of the Notice of Award by the supplier, it was found out that **VIC IMPERIAL APPLIANCE CORPORATION** requires payment first which is in conflict to the Terms of Payment and instruction No. 12 of the Request for Quotation which states "within 15 days after inspection and acceptance and shall be made through Land Bank's LDDAP-ADA/Bank Transfer Facility". Therefore, **VIC IMPERIAL APPLIANCE CORPORATION** is considered as non-responsive.

WHEREAS, a cancellation letter was submitted by **VIC IMPERIAL APPLIANCE CORPORATION** on Jul. 10, 2024 to cancel the Notice of Award received by the supplier due to the conflicting mode of payment established by their company and the agency.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **NIG MARKETING CORPORATION** is considered as the 2nd lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Split Type Aircon with Full Installation** to **NIG MARKETING CORPORATION** in the amount of **One Hundred Thousand One Hundred Forty Pesos Only (Php 100,140.00)**.


