

**BAC Resolution No. 000, Series of 2024**

**Procurement of Food Services for the Conduct of Local Farmer Technicians (LFT) Quarterly Meeting**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Food Services for the Conduct of Local Farmer Technicians (LFT) Quarterly Meeting** with an Approved Budget for the Contract (ABC) of **Forty-Five Thousand Pesos Only (Php 45,000.00)** for lot 1 and **Forty-Five Thousand Pesos Only (Php 45,000.00)** for lot 3 and **Sixty Thousand Pesos Only (Php 60,000.00)** for lot 5 and **Sixty-One Thousand Two Hundred Pesos Only (Php 61,200.00)** for lot 6.

WHEREAS, on July 23, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **ATI-ATIHAN FESTIVAL HOTEL CORPORATION**; (2) **ORO LUCKY CATERING**; (3) **ROYAL SUITES CONDOTEL** for lot 1 and (1) **NESTAS HILLTOP HOTEL & RESTAURANT**; (2) **MP STAR CORPORATION**; (3) **GERRY ROXAS FOUNDATION, INC.** for lot 3 and (1) **J&P CANTINA, INC.**; (2) **KEATTLE'S CATERING**; (3) **KRS CATERING & SERVICES** for lot 5 and (1) **MHELAY'S CATERING SERVICES**; (2) **MAY'S ORGANIC GARDEN RESTAURANT**; (3) **A&N EATERY** for lot 6.

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on July 30, 2024, **ATI-ATIHAN FESTIVAL HOTEL**, **ORO LUCKY CATERING** and **ROYAL SUITES CONDOTEL** submitted their quotations for lot 1 and **NESTAS HILLTOP HOTEL & RESTAURANT**, **MP STAR CORPORATION** and **GERRY ROXAS FOUNDATION, INC.** submitted their quotations for lot 3 and **J&P CANTINA, INC.**, **KEATTLE'S CATERING** and **KRS CATERING & SERVICES** submitted their quotations for lot 5 and **MHELAY'S CATERING SERVICES**, **MAY'S ORGANIC GARDEN RESTAURANT** and **A&N EATERY** submitted their quotations for lot 6.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ATI-ATIHAN FESTIVAL HOTEL** is considered as the lowest offeror for lot 1 and **GERRY ROXAS FOUNDATION, INC.** for lot 3 and **J&P CANTINA, INC.** for lot 5 and **A&N EATERY** for lot 6 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Food Services for the Conduct of Local Farmer Technicians (LFT) Quarterly Meeting** to **ATI-ATIHAN FESTIVAL HOTEL** in the amount of **Forty Four Thousand One Hundred Pesos Only (Php 44,100.00)** for lot 1 and to **GERRY ROXAS FOUNDATION, INC.** in the amount of **Forty Five Thousand Pesos Only (Php 45,000.00)** for lot 3 and to **J&P CANTINA, INC.** in the amount of **Fifty Six Thousand One Hundred Fifty Pesos Only (Php 56,150.00)** for lot 5 and to **A&N EATERY** in the amount of **Fifty Four Thousand Pesos Only (Php 54,000.00)** for lot 6.
