

BAC Resolution No. 248, Series of 2024

Procurement of Catering Services for the Conduct of Training on Rice and Poultry & Livestock Production for Palayamanan

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Catering Services for the Conduct of Training on Rice and Poultry & Livestock Production for Palayamanan with an Approved Budget for the Contract (ABC) of One Hundred Fifty Thousand Pesos Only (Php 150,000.00) for lot 2 and One Hundred Fifty Thousand Pesos Only (Php 150,000.00) for lot 3.

WHEREAS, on Jul. 31, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) GERRY ROXAS FOUNDATION, INC.; (2) NESTAS HILLTOP HOTEL & RESTAURANT; (3) MP STAR CORPORATION for lot 2 and (1) MBMD CATERING SERVICES; (2) MOM'S SMALL HOTEL AND RESTAURANT; (3) CARMEL'S RESTAURANT for lot 3.

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on Aug. 7, 2024, GERRY ROXAS FOUNDATION, INC., NESTAS HILLTOP HOTEL & RESTAURANT and MP STAR CORPORATION submitted their quotations for lot 2 and MBMD CATERING SERVICES, MOM'S SMALL HOTEL AND RESTAURANT, CARMEL'S RESTAURANT for lot 3.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, GERRY ROXAS FOUNDATION, INC. is considered as the lowest offeror for lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, MBMD CATERING SERVICES and MOM'S SMALL HOTEL AND RESTAURANT is both considered as the lowest offeror for lot 3. However, upon careful evaluation, validation, and verification of the submitted RFQ, MBMD CATERING SERVICES has no signature on the printed name of the supplier, Therefore, considered as non-responsive.

WHEREAS, MOM'S SMALL HOTEL AND RESTAURANT is considered as the lowest responsive offeror for lot 3 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.


