

**BAC Resolution No. 570, Series of 2024****Procurement of Other Supplies**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Other Supplies** with an Approved Budget for the Contract (ABC) of **One Hundred Fifty-One Thousand One Hundred Twenty-Two Pesos Only (Php 151,122.00)** for lot 1 and **Ninety-Six Thousand Five Hundred Ninety-Three Pesos Only (Php 96,593.00)** for lot 3 and **Seven Thousand Eight Hundred Pesos Only (Php 7,800.00)** for lot 4.

**WHEREAS**, on June 20, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the prospective suppliers related to the said procurement.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 1:00 PM. on June 27, 2024, **NEW HONG CHIU HARDWARE** and **ELM INDUSTRIAL SALES** submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **NEW HONG CHIU HARDWARE** is considered as the lowest offeror for lot 1 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ELM INDUSTRIAL SALES** is considered as the lowest offeror for lot 3 and lot 4 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by **NEW HONG CHIU HARDWARE** in the amount of **One Hundred One Thousand One Hundred Pesos Only (Php 101,100.00)** is the lowest quotation for lot 1 and by **ELM INDUSTRIAL SALES** in the amount of **Eighty-Six Thousand Two Hundred Twenty Pesos Only (Php 86,220.00)** for lot 3 and in the amount of **Seven Thousand Two Hundred Fifty Pesos Only (Php 7,250.00)** for lot 4.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.




NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Other Supplies to NEW HONG CHIU HARDWARE** in the amount of **One Hundred One Thousand One Hundred Pesos Only (Php 101,100.00)** is the lowest quotation for lot 1 and to **ELM INDUSTRIAL SALES** in the amount of **Eighty-Six Thousand Two Hundred Twenty Pesos Only (Php 86,220.00)** for lot 3 and in the amount of **Seven Thousand Two Hundred Fifty Pesos Only (Php 7,250.00)** for lot 4.
