



BAC Resolution No. 510, Series of 2024

Procurement of Van Rentals for the conduct of various activity for SRI Project

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Van Rentals for the conduct of various activity for SRI Project** with an Approved Budget for the Contract (ABC) of **One Hundred Two Thousand Pesos Only (Php 102,000.00)** for lot 1 and **Sixty-Six Thousand Pesos Only (Php 66,000.00)** for lot 2 and **One Hundred Fifty-Six Thousand Pesos Only (Php 156,000.00)** for lot 3 and **Eighty-Four Thousand Pesos Only (Php 84,000.00)** for lot 4.

WHEREAS, on July 11, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **RJ TRANSPORT SERVICES**; (2) **BENNCH TRANSPORT SERVICES**; (3) **EXECUTIVE ELEGANCE CHARTERS, OPC**; (4) **7SQ OPC**

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on July 15, 2024, **RJ TRANSPORT SERVICES, BENNCH TRANSPORT SERVICES, EXECUTIVE ELEGANCE CHARTERS, OPC** and **7SQ OPC** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **BENNCH TRANSPORT SERVICES** is considered as the lowest offeror for lot 1, 2 and 4 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, **RJ TRANSPORT SERVICES** and **BENNCH TRANSPORT SERVICES** complied with the specification and other forms and conditions stated in the Request for Quotations and quoted the same price in the amount of **One Hundred Eight Thousand Pesos Only (Php 108,000.00)** for lot 3 which is advantageous to the government.

WHEREAS, under RA 9184 a tie breaking process by toss coin is authorized.

WHEREAS, a tie breaking process was conducted on July 18, 2024 at 2:15 PM at RCPC Library, WESVIARC, Hamungaya, Jaro, Iloilo City. During the process by toss coin, **BENNCH TRANSPORT SERVICES** emerged as the winner.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Van Rentals for the conduct of various activity for SRI Project** to **BENNCH TRANSPORT SERVICES** in the amount of **Eighty Two Thousand Nine Hundred Sixty Pesos Only (Php 82,960.00)** for lot 1 and **Fifty Four Thousand Eight Hundred Ninety Pesos Only (Php 54,890.00)** for lot 2 and **One Hundred Eight Thousand Pesos Only (Php 108,000.00)** for lot 3 and **Seventy Seven Thousand Two Hundred Eighty Pesos Only (Php 77,280.00)** for lot 4.
