

BAC Resolution No. 0577, Series of 2024**Procurement of Catering Services for the conduct of Briefing and Orientation for AgroEcology Rice Based Farming Project**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Catering Services for the conduct of Briefing and Orientation for AgroEcology Rice Based Farming Project** with an Approved Budget for the Contract (ABC) of **Thirty Thousand Pesos Only (Php 30,000.00)** for lot 1 and for lot 2.

WHEREAS, on July 18, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **MVW RESTAURANT & TOURIST INN**; (2) **NESTAS HILLTOP HOTEL & RESTAURANT**; (3) **GERRY ROXAS FOUNDATION, INC.** for lot 1 and (1) **MVW RESTAURANT & TOURIST INN**; (2) **NESTAS HILLTOP HOTEL & RESTAURANT**; (3) **GERRY ROXAS FOUNDATION, INC.**; (4) **KRS CATERING & SERVICES**; (5) **KEATTLE'S CATERING**; (6) **J&P CANTINA INC.** for lot 2.

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on July 22, 2024, **MVW RESTAURANT & TOURIST INN**, **NESTAS HILLTOP HOTEL & RESTAURANT** and **GERRY ROXAS FOUNDATION, INC.** submitted their quotations for lot 1 and **MVW RESTAURANT & TOURIST INN**, **NESTAS HILLTOP HOTEL & RESTAURANT**, **GERRY ROXAS FOUNDATION, INC.**, **KRS CATERING & SERVICES**, **KEATTLE'S CATERING** and **J&P CANTINA INC.** submitted their quotations for lot 2.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **GERRY ROXAS FOUNDATION, INC.** is considered as the lowest offeror for lot 1.


WHEREAS, for lot 2 **GERRY ROXAS FOUNDATION, INC.** and **J&P CANTINA INC.** are both considered as lowest offerors. Therefore, a tie breaking process (toss coin) is required to determine the winner provided under RA 9184. However, upon informing both suppliers, **GERRY ROXAS FOUNDATION, INC.** decided to cancel their bid for lot 2. ✓

WHEREAS, a letter for cancellation of bid for lot 2 is sent by **GERRY ROXAS FOUNDATION, INC.** on July 23, 2024. ✓

WHEREAS, **J&P CANTINA INC.** is considered as the lowest offeror for lot 2 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number. ✓

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Catering Services for the conduct of Briefing and Orientation for AgroEcology Rice Based Farming Project** to **GERRY ROXAS FOUNDATION, INC.** in the amount of **Thirty Thousand Pesos Only (Php 30,000.00)** for lot 1 and to **J&P CANTINA INC.** in the amount of **Thirty Thousand Pesos Only (Php 30,000.00)** for lot 2.


