WHEREAS, the detailed evaluation of the bids conducted on, June 26, 2024, resulted in the following:

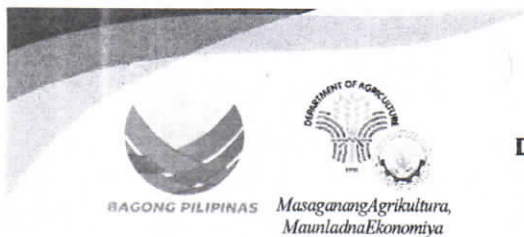

- To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.







