WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Supply and Delivery of Five (5) Units Forage Chopper** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 1,500,000.00**;


