(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Supply and Delivery of Four (4) Units Hammer Mill** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 1,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their application for eligibility and bid offer;

- To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.









