

BAC Resolution No. 0594

Series of 2024

WHEREAS, the Department of Agriculture has an original project, **Procurement of Supply and Delivery of Twenty-Seven (27) Units Hand Tractor (Ride On)** with an Approved Budget for the Contract (ABC) of **Ten Million Nine Hundred Thirty-Five Thousand Pesos Only (Php 10,935,000.00)**;

WHEREAS, the Bids and Awards Committee (BAC) for Agri-Infra, Farm Machineries and Vehicle (AMV) has issued a Resolution No. 2024-019 dated January 24, 2024 recommending the award of Contract to **AGRICOM VISAYAS, INC.** in the amount of **Nine Million Four Hundred Seventeen Thousand Six Hundred Pesos Only (Php 9,417,600.00)**;

WHEREAS, the BAC Resolution was approved by the Head of the Procuring Entity and a Notice to Proceed was issued and received by **AGRICOM VISAYAS, INC.** on **April 12, 2024**;

WHEREAS, twenty-seven (27) Units Hand Tractor (Ride On) were delivered on April 16, 2024;

WHEREAS, a Purchase Request (PR) for the **Repeat Order for the Procurement of Supply and Delivery of Hand Tractor (Ride On) with Accessories** with an ABC of **Two Million Ninety-two Thousand Eight Hundred Pesos Only (Php 2,092,800.00)** was made;

WHEREAS, under Section 51, Article XVI of R.A. 9184 and its Revised Implementing Rules and Regulations and when provided for in the Annual Procurement Plan, **REPEAT ORDER** as an alternative Method of Procurement may be allowed wherein the Procuring Entity directly procure **MACHINERIES** from the previously contracted winning bidder under the following conditions;

- A. The unit price offered by Modern time Enterprises, Inc. under Repeat Order is equal to or lower than that provided in the original contract;
- B. The repeat order does not result in splitting of requisitions or purchase orders;
- C. The repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the original contract wherein partial delivery, inspection and acceptance of the goods was already made; and
- D. The repeat order does not exceed twenty-five percent (25%) of the quantity of each item of the original contract.

THEREFORE, the **BIDS AND AWARDS COMMITTEE** for Agri-Infra, Farm Machineries and Vehicle **RESOLVE** as it is hereby **RESOLVED** that **REPEAT ORDER** shall be the mode of procurement in favor of **AGRICOM VISAYAS, INC.** for the **Procurement of Supply and Delivery of Hand Tractor (Ride On) with Accessories**.
