Procurement of Food and Accommodation for the Conduct of Evaluation of Organic Agriculture Livelihood Project (OALP) Proposals for FY 2026 at Iloilo City

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Food and Accommodation for the Conduct of Evaluation of Organic Agriculture Livelihood Project (OALP) Proposals for FY 2026 at Iloilo City** with an Approved Budget for the Contract (ABC) of **Ninety-Four Thousand Five Hundred Pesos Only (Php 94,500.00)**.

WHEREAS, on August 21, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **EON CENTENNIAL RESORT HOTEL & WATERPARK**; (2) **3L PROPERTIES & ALPHA DEVELOPMENT CORPORATION**; (3) **MO2 WESTOWN HOTEL**

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on August 28, 2024, **EON CENTENNIAL RESORT HOTEL & WATERPARK, 3L PROPERTIES & ALPHA DEVELOPMENT CORPORATION** and **MO2 WESTOWN HOTEL** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **EON CENTENNIAL RESORT HOTEL & WATERPARK** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.


