

BAC Resolution No. 0554, Series of 2024

Procurement of Supply and Delivery of Hand Tractor

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Hand Tractor** with an Approved Budget for the Contract (ABC) of **Six Hundred Seventy Thousand Pesos Only (Php 670,000.00)**.

WHEREAS, on July 10, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **NEW HONG CHIU HARDWARE**; (2) **MEDAL AGRI TRADING**; (3) **EDMM FARM IMPLEMENTS TRADING**; (4) **AGRIMACH CG CORPORATION**; (5) **AGRICOM VISAYAS, INC.**; (6) **AGRICULTURAL IMPLEMENTS TOOL**

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on July 17, 2024, **NEW HONG CHIU HARDWARE, MEDAL AGRI TRADING, EDMM FARM IMPLEMENTS TRADING, AGRIMACH CG CORPORATION, AGRICOM VISAYAS, INC.** and **AGRICULTURAL IMPLEMENTS TOOL** submitted their quotations.

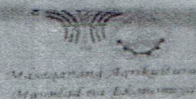
WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **AGRICOM VISAYAS, INC.** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **AGRICOM VISAYAS, INC.** in the amount of **Six Hundred Forty Thousand Pesos Only (Php 640,000.00)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.


WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.
