**Procurement of Food and Accommodation during the conduct of various activities of the Market Development Section in the Province of Negros Occidental**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the Procurement of Food and Accommodation during the conduct of various activities of the Market Development Section in the Province of Negros Occidental with an Approved Budget for the Contract (ABC) of Seventy-Four Thousand Four Hundred Pesos Only (Php 74,400.00).

**WHEREAS**, before the lapse of the deadline for submission of quotation at 1:00 PM. on July 30, 2024, **MO2 WESTOWN HOTEL & CONVENTION HALL**, **MAY'S ORGANIC GARDEN RESTAURANT**, **CAPITOL CENTRAL HOTEL VENTURES INC.** and **L'FISHER HOTEL** submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **MAY'S ORGANIC GARDEN RESTAURANT** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
