

## BAC Resolution No. 1020, Series of 2024

Procurement of Labor and Materials for the Pull-out and Reinstallation of Air Conditioning Unit from RAED Office (BPI Compound) to Identified Offices

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Labor and Materials for the Pull-out and Reinstallation of Air Conditioning Unit from RAED Office (BPI Compound) to Identified Offices with an Approved Budget for the Contract (ABC) of Seventy-Eight Thousand Six Hundred Pesos Only (Php 78,600.00).

WHEREAS, on July 23, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) LDC REFRIGERATION & AIRCONDITIONING INC.; (2) GEOMER AIRCONDITIONING WORKS & SALES INC.; (3) COOL AIR STREAM SALES & SERVICES INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on July 30, 2024, LDC REFRIGERATION & AIRCONDITIONING INC., GEOMER AIRCONDITIONING WORKS & SALES INC. and COOL AIR STREAM SALES & SERVICES INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, COOL AIR STREAM SALES & SERVICES INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by COOL AIR STREAM SALES & SERVICES INC. in the amount of **Seventy-Seven Thousand Three Hundred Twenty-Five Pesos Only (Php 77,325.00)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Labor and Materials for the Pull-out and Reinstallation of Air Conditioning Unit from RAED Office (BPI Compound) to Identified Offices to COOL AIR STREAM SALES & SERVICES INC. in the amount of **Seventy-Seven Thousand Three Hundred Twenty-Five Pesos Only (Php 77,325.00)**.
