Procurement of Catering Services for the conduct of Training on Organic Fertilizer and Botanical Pesticide Preparation

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Catering Services for the conduct of Training on Organic Fertilizer and Botanical Pesticide Preparation** with an Approved Budget for the Contract (ABC) of **Two Hundred Ten Thousand Pesos Only (Php 210,000.00)** for lot 1 and **One Hundred Five Thousand Pesos Only (Php 105,000.00)** for lot 3 and **One Hundred Five Thousand Pesos Only (Php 105,000.00)** for lot 4.

WHEREAS, on August 14, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **J&P CANTINA, INC.**; (2) **KRS CATERING & SERVICES**; (3) **KEATTLE'S CATERING** for lot 1 and (1) **NESTA'S HILLTOP HOTEL & RESTAURANT**; (2) **GERRY ROXAS FOUNDATION, INC.**; (3) **MP STAR CORPORATION** for lot 3 and (1) **ORO LUCKY CATERING SERVICES**; (2) **ATI-ATIHAN FESTIVAL HOTEL CORP.**; (3) **IBON MPC** for lot 4.

WHEREAS, before the lapse of the deadline for submission of quotation at 1:00 PM. on August 21, 2024, **J&P CANTINA, INC.**, **KRS CATERING & SERVICES**, **KEATTLE'S CATERING** submitted their quotations for lot 1 and **NESTA'S HILLTOP HOTEL & RESTAURANT**, **GERRY ROXAS FOUNDATION, INC.**, **MP STAR CORPORATION** for lot 3 and **ORO LUCKY CATERING SERVICES**, **ATI-ATIHAN FESTIVAL HOTEL CORP.**, **IBON MPC** for lot 4.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **J&P CANTINA, INC.** is considered as the lowest offeror for lot 1 and **GERRY ROXAS FOUNDATION, INC.** for lot 3 and **ORO LUCKY CATERING SERVICES** for lot 4 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Catering Services for the conduct of Training on Organic Fertilizer and Botanical Pesticide Preparation** to **J&P CANTINA, INC.** in the amount of **Two Hundred Nine Thousand Eight Hundred Twenty Five Pesos Only (Php 209,825.00)** for lot 1 and to **GERRY ROXAS FOUNDATION, INC.** in the amount of **One Hundred Five Thousand Pesos Only (Php 105,000.00)** for lot 3 and to **ORO LUCKY CATERING SERVICES** in the amount of **Ninety Six Thousand Two Hundred Fifty Pesos Only (Php 96,250.00)** for lot 4.
