Provision of Food during the conduct of SAAD Western Visayas FY 2024 Consultation Meeting with Farmer Beneficiaries and LGUs (Lot 1 & Lot 2)

WHEREAS, the Department of Agriculture has a Purchase Request for the Provision of Food during the conduct of SAAD Western Visayas FY 2024 Consultation Meeting with Farmer Beneficiaries and LGUs (Lot 1 & Lot 2) with an Approved Budget for the Contract (ABC) of Sixty Thousand Pesos Only (Php 60,000.00).

WHEREAS, on August 02, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) LAMARIE CAFE; (2) KISSES FOODHAUZ & CATERING SERVICES; (3) TONGTONG'S FOODHOUSE.


WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on August 09, 2024, LAMARIE CAFE, KISSES FOODHAUZ & CATERING SERVICES and TONGTONG'S FOODHOUSE submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation LAMARIE CAFÉ for Lot 1 and KISSES FOODHAUZ & CATERING SERVICES for Lot 2 is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.


NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Provision of Food during the conduct of SAAD Western Visayas FY 2024 Consultation Meeting with Farmer Beneficiaries and LGUs (Lot 1 & Lot 2) to LAMARIE CAFE in the amount of Thirty Thousand Pesos Only (Php 30,000.00) for Lot 1 and KISSES FOODHAUZ & CATERING SERVICES in the amount of Thirty Thousand Pesos Only (Php 30,000.00) for Lot 2.
