**Procurement of Supply and Delivery of Various Farm Tools, Supplies and Ferti**

**WHEREAS**, the Department of Agriculture has a Purchase Request for Procurement of Supply and Delivery of Various Farm Tools, Supplies and Fertilizers with an Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos Only (Php 120,050.00) for lot 1 and Thirty-Five Thousand Pesos Only 35,000.00) for lot 2.

**WHEREAS**, on July 31, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers viz: (1) RS AGRO INDUSTRIAL CORP.; (2) ILOILO NEW AGRICULTURAL MARKETING AND GENERAL SERVICES, INC.; (3) KMK AGRI PRODUCTS TRADING; (4) JUAN AGRI-VENTURES, INC. for lot 1 and lot 2.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 1:00 PM on August 7, 2024, RS AGRO INDUSTRIAL CORP., ILOILO NEW AGRICULTURAL MARKETING AND GENERAL SERVICES, INC., KMK AGRI PRODUCTS TRADING and JUAN AGRI-VENTURES, INC. submitted their quotations for lot 1 and lot 2.

**WHEREAS**, upon careful evaluation, validation, and verification of all documentary requirements and specification stated in the Request for Quotation, RS AGRI PRODUCTS TRADING is considered as the lowest offeror for lot 1 and lot 2 and its price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by KMK AGRI PRODUCTS TRADING in the amount of **One Hundred Fifteen Thousand Three Hundred Eighty-Five Pesos Only (Php 115,385.00)** is the lowest quotation for lot 1 and in the amount of **Twenty-Eight Thousand Eight Hundred Pesos Only (Php 28,800.00)** for lot 2.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Various Farm Tools, Supplies and Fertilizers to KMK AGRI PRODUCTS TRADING in the amount of **One Hundred Fifteen Thousand Three Hundred Eighty-Five Pesos Only (Php 115,385.00)** for lot 1 and in the amount of **Twenty-Eight Thousand Eight Hundred Pesos Only (Php 28,800.00)** for lot 2.
