(Resolution to Declare the Responsive Bidder)

**WHEREAS**, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Works for the Construction of 30 Sow Level Production Farm Facility under INSPIRE Program (Lot 7) 2<sup>nd</sup> Batch** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 5,953,978.35**;

**WHEREAS**, in response to the said advertisement, two (2) bidders submitted their application for eligibility and bid offer;

**WHEREAS**, the two (2) bidders "passed" the preliminary examination of bid;


