(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the Procurement of Supply and Delivery of Assorted Vegetable Seeds in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 1,070,778.75;

WHEREAS, in response to the said advertisement, two (2) bidders submitted its application for eligibility and bid offer;

WHEREAS, the two (2) bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposal of the two (2) bidders was found to be substantially complying:

WHEREAS, the detailed evaluation of the bids conducted on, June 19, 2024 resulted in the following:

WHEREAS, with the foregoing evaluation results, Acacia Agri-ventures & Trading Corp. was found to be the Lowest Calculated Bidder (LCB);

WHEREAS, upon careful evaluation, validation and verification of all the eligibility, technical and financial requirements submitted by the Lowest Calculated Bidder, Acacia Agri-ventures & Trading Corp. failed to pass the post qualification conducted by Technical Working Group (TWG) due to the ground that the bidder has not complied with the Agency's requirement as required by the end-user. Therefore, Acacia Agri-ventures & Trading Corp. considered as Non-Responsive Bidder.

WHEREAS, the same evaluation process was conducted to 2nd Lowest Calculated Bidder and upon careful evaluation, validation and verification of all the eligibility, technical and financial requirements submitted by the 2nd Lowest Calculated Bidder, Iloilo New Agri-Industrial Marketing & Gen. Services, Inc. has found to be responsive.

NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;

- To declare Iloilo New Agri-Industrial Marketing & Gen. Services, Inc. as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Procurement of Supply and Delivery of Assorted Vegetable Seeds in the amount of Php 1,049,796.00; and
- To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.






