WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Works for the Construction of 30 Sow Level Production Farm Facility at Brgy. Tu-og, Leon, Iloilo (Lot 1)** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 5,953,978.35**;

WHEREAS, in response to the said advertisement, three (3) bidders submitted their application for eligibility and bid offer;

WHEREAS, the three bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposals of the four bidders were found to be substantially complying:


