WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Works for the Construction of 30 Sow Level Production Farm Facility (Lot 6) at Brgy. Bantayan, San Enrique, Iloilo** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 5,953,978.35**;

WHEREAS, in response to the said advertisement, three (3) bidders submitted their application for eligibility and bid offer;

WHEREAS, the three bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposals of the three bidders were found to be substantially complying:

NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;



- To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.




