Procurement of Food Services for the conduct of Local Farmer Technicians (LFT) Quarterly Meeting

WHEREAS, the* Department of Agriculture has a Purchase Request for the **Procurement of Food Services for the conduct of Local Farmer Technicians (LFT) Quarterly Meeting** with an Approved Budget for the Contract (ABC) of **Forty Five Thousand Pesos Only (Php 45,000.00)** for lot 1 and **Fifty Two Thousand Pesos Only (Php 52,000.00)** for lot 2 and **Forty Five Thousand Pesos Only (Php 45,000.00)** for lot 3 and **Nineteen Thousand Two Hundred Pesos Only (Php 19,200.00)** for lot 4 and **Ninety Thousand Pesos Only (Php 90,000.00)** for lot 5 and **Sixty One Thousand Two Hundred Pesos Only (Php 61,200.00)** for lot 6.
