

BAC Resolution No. 001, Series of 2024

Procurement of Supply and Delivery of 6 Unit Hand Tractor

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of 6 Unit Hand Tractor** with an Approved Budget for the Contract (ABC) of **Nine Hundred thousand Pesos Only (Php 900,000.00)**.

WHEREAS, on October 4, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **AGRICOM VISAYAS, INC.**; (2) **NEW HONG CHIU HARDWARE**; (3) **MEDAL AGRI TRADING**

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon. on October 11, 2024, **AGRICOM VISAYAS, INC., NEW HONG CHIU HARDWARE** and **MEDAL AGRI TRADING** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **AGRICOM VISAYAS, INC.** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **AGRICOM VISAYAS, INC.** in the amount of **Eight Hundred Eighty-Two Thousand Pesos Only (Php 882,000.00)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of 6 Unit Hand Tractor to AGRICOM VISAYAS, INC.** in the amount of **Eight Hundred Eighty-Two Thousand Pesos Only (Php 882,000.00)**
