

BAC Resolution No. 0886, Series of 2024

Procurement of Supply and Delivery of Experimental Animals

WHEREAS, the Department of Agriculture has a Purchase Request for **Procurement of Supply and Delivery of Experimental Animals** with an initial Budget for the Contract (ABC) of **Two Hundred Twenty-Eight Thousand Pesos Only (Php 228,000.00)**.

WHEREAS, on Nov. 21, 2024, the BAC, thru its Secretariat, initiated procurement activity by sending the Request for Quotation (RFQ) to the prospective suppliers, viz: (1) **JEZRA DARAG AGRI TRADING**; (2) **PACIFICA SUPPLIES INC.**; (3) **RG POULTRY SUPPLIES**

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon on Nov. 28, 2024, **JEZRA DARAG AGRI TRADING, PACIFICA AGRIVET SUPPLIES** and **RG POULTRY SUPPLIES** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of the documentary requirements and specification stated in the Request for Quotation (RFQ), **DARAG AGRI TRADING** is considered as the lowest offeror and with price within the ABC and it was found to be compliant with the eligibility requirements evidenced by the submission of its 2024 Mayor's/Business Permit and professional PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **JEZRA DARAG AGRI TRADING** in the amount of **Two Hundred Twenty-Seven Thousand Four Hundred Pesos Only (Php 227,400.00)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, **WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Experimental Animals** to **JEZRA DARAG AGRI TRADING** in the amount of **Two Hundred Twenty-Seven Thousand Four Hundred Pesos Only (Php 227,400.00)**.
