## BAC Resolution No. 0869, Series of 2024

### Procurement of Works for the Establishment of Chicken Multiplier Facility (Lot 1)

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Works for the Establishment of Chicken Multiplier Facility (Lot 1) with an Approved Budget for the Contract (ABC) of Nine Hundred Fifty-Four Thousand Pesos Only (Php 954,000.00).

WHEREAS, on Nov. 8, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **EQUALS FIVE CONSTRUCTION**; (2) **R AND A HARDWARE AND CONSTRUCTION SUPPLIES**; (3) **RGSV CONSTRUCTION**; (4) **J.C. TAMAYO ENTERPRISES**; (5) **BABA BUILDERS OPC**; (6) **J.C. ALBASON BUILDERS AND SUPPLY**

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Nov. 15, 2024, **EQUALS FIVE CONSTRUCTION, R AND A HARDWARE AND CONSTRUCTION SUPPLIES, RGSV CONSTRUCTION, J.C. TAMAYO ENTERPRISES, BABA BUILDERS OPC** and **J.C. ALBASON BUILDERS AND SUPPLY** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **EQUALS FIVE CONSTRUCTION** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **EQUALS FIVE CONSTRUCTION** in the amount of **Eight Hundred Fifty Three Thousand Four Hundred Forty Three Pesos & 38/100 Only (Php 853,443.38)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Works for the Establishment of Chicken Multiplier Facility (Lot 1) to EQUALS FIVE CONSTRUCTION** in the amount of **Eight Hundred Fifty Three Thousand Four Hundred Forty Three Pesos & 38/100 Only (Php 853,443.38)**.
