

BAC Resolution No. 0704, Series of 2024

Lay-out and Printing of SAAD Program Unlad Lokal Coffee Table Book

WHEREAS, the Department of Agriculture has a Purchase Request for the Lay-out and Printing of SAAD Program Unlad Lokal Coffee Table Book with an Approved Budget for the Contract (ABC) of One Hundred Forty-Three Thousand Pesos Only (Php 143,000.00).

WHEREAS, on October 15, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **NO BOUNDARIES ADVERTISING AND EVENTS**; (2) **AG3 COLORS PRINTING PRESS**; (3) **ILOILO PRINTING AND SERVICES**.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 pm. on October 22, 2024, **NO BOUNDARIES ADVERTISING AND EVENTS, AG3 COLORS PRINTING PRESS** and **ILOILO PRINTING AND SERVICES** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **NO BOUNDARIES ADVERTISING AND EVENTS** is considered as the lowest offeror but did not meet the terms and conditions. Hence, **ILOILO PRINTING AND SERVICES** is considered as the second lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **ILOILO PRINTING AND SERVICES** in the amount of **One Hundred Forty Thousand Pesos Only (Php 140,000.00)** is the second lowest quotation. ✓

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Lay-out and Printing of SAAD Program Unlad Lokal Coffee Table Book to **ILOILO PRINTING AND SERVICES** in the amount of **One Hundred Forty Thousand Pesos Only (Php 140,000.00)**.


