

BAC Resolution No. 0874, Series of 2024

Procurement of Supply and Delivery of Various Pesticide

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Various Pesticide** with an Approved Budget for the Contract (ABC) of **Seven Hundred Eighty-Seven Thousand One Hundred Fourteen Pesos Only (Php 787,114.00)**.

WHEREAS, on October 21, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **ENVIRO SCOPE SYNERGY INC.**; (2) **VERCA AGRO CHEM**; (3) **RS AGRO INDUSTRIAL CORPORATION**; (4) **MODEL AGRO SALES**; (5) **BOOTING STAGE AGRIVET SUPPLY**; (6) **M'CORNER AGRI SUPPLY**; (7) **JUANTONG AGRI-VENTURES, INC.**; (8) **VMO AGRICULTURAL FARM SUPPLIES**; (9) **ANGEL OF NATURES FARM & SERVICES**

WHEREAS, before the lapse of the deadline for submission of quotation at 12:00 noon, on October 28, 2024, **ENVIRO SCOPE SYNERGY INC.**, **VERCA AGRO CHEM**, **RS AGRO INDUSTRIAL CORPORATION**, **MODEL AGRO SALES**, **BOOTING STAGE AGRIVET SUPPLY**, **M'CORNER AGRI SUPPLY**, **JUANTONG AGRI-VENTURES, INC.**, **VMO AGRICULTURAL FARM SUPPLIES** and **ANGEL OF NATURES FARM & SERVICES** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ENVIRO SCOPE SYNERGY INC.** and **VERCA AGRO CHEM** are the lowest offeror but failed to comply with the required specifications. **RS AGRO INDUSTRIAL CORPORATION** is considered as the 3rd lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **RS AGRO INDUSTRIAL CORPORATION** in the amount of **Five Hundred Sixteen Thousand Six Hundred Seventy-Two Pesos Only (Php 516,672.00)** is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Various Pesticide** to **RS AGRO INDUSTRIAL CORPORATION** in the amount of **Five Hundred Sixteen Thousand Six Hundred Seventy-Two Pesos Only (Php 516,672.00)**.




