

**BAC Resolution No. 0906, Series of 2024**

**Procurement of Supply and Delivery of Drugs and Biologics**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Drugs and Biologics** with an Approved Budget for the Contract (ABC) of **One Hundred Seventeen Thousand Five Hundred Twenty-Three Pesos Only (Php 117,523.00)**.

**WHEREAS**, on November 12, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **JAMELE POULTRY SUPPLY**; (2) **MUEGA MAGLANTAY AGRICULTURAL SUPPLY**.

**WHEREAS**, before the lapse of the deadline for submission of quotation at 5:00 pm. on November 20, 2024, **JAMELE POULTRY SUPPLY** and **MUEGA MAGLANTAY AGRICULTURAL SUPPLY** submitted their quotations.

**WHEREAS**, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **MUEGA MAGLANTAY AGRICULTURAL SUPPLY** is considered as the lowest offeror but did not complied DA's Specification. Hence, **JAMELE POULTRY SUPPLY** is considered as the second lowest calculated and Responsive Bidder and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

**WHEREAS** the TWG likewise determined that the financial proposal submitted by **JAMELE POULTRY SUPPLY** in the amount of **One Hundred Seventeen Thousand Five Hundred Twenty Pesos Only (Php 117,520.00)** is the lowest quotation.

**WHEREAS** the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

**WHEREAS** the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

**NOW, THEREFORE, WE**, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Drugs and Biologics** to **JAMELE POULTRY SUPPLY** in the amount of **One Hundred Seventeen Thousand Five Hundred Twenty Pesos Only (Php 117,520.00)**.
