

## BAC Resolution No. 067, Series of 2024

### Procurement of Labor and Services for Surveying of Land located at ROS Sigma Capiz, Malapad Cogon, Capiz

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Labor and Services for Surveying of Land located at ROS Sigma Capiz, Malapad Cogon, Capiz with an Approved Budget for the Contract (ABC) of Sixty Thousand Pesos Only (Php 60,000.00).
