

RESOLUTION NO. 267

(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Works for the Construction of 30 Sow Level Production Farm Facility at Brgy. Buga, Igaras, Iloilo (Lot 2)** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 5,953,978.35**;

WHEREAS, in response to the said advertisement, one (1) bidder submitted its application for eligibility and bid offer;

WHEREAS, the lone bidder “passed” the preliminary examination of bid;

WHEREAS, the bid proposal of the lone bidder was found to be substantially complying:


