

## BAC Form No. 0411 - Issues of 2024

Procurement of Supply and Delivery of Materials for Mushroom Production Training

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Supply and Delivery of Materials for Mushroom Production Trainings with an Appraised Budget for the Contract (ARC) of Two Hundred Fifty Two Thousand Three Hundred Pesos Only (Php 252,300.00).

WHEREAS, on Nov. 27, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective vendors, viz. (1) THREE M ONE ENTERPRISES, NEW HONG CITY, RICHMONT ENTERPRISES, COMALLES ALBERTO & HARDWARE and RICE CONSUMERS FROM CONSUMER GOODS TRADING

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM, on Dec. 6, 2024, THREE M ONE ENTERPRISES, NEW HONG CITY, RICHMONT ENTERPRISES, COMALLES ALBERTO & HARDWARE and RICE CONSUMERS FROM CONSUMERS submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, THREE M ONE ENTERPRISES is considered as the lowest bidder and with price quotation within the ARC and it was found to be compliant with the eligibility criteria as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilCPG Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by THREE M ONE ENTERPRISES is the amount of Two Hundred Fifty One Thousand Three Hundred Pesos Only (Php 251,600.00) is the lowest quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation and is the technical requirements of the project and has been found to be compliant.

WHEREAS the report concluding the results of the TWG evaluation is attached herewith Annex "A," and made an integral part hereof.

NOW, THEREFORE, all the members of the BAC, AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the BAC for his consideration and approval, the award of contract for the Procurement of Supply and Delivery of Materials for Mushroom Production Training to THREE M ONE ENTERPRISES in the amount of Two Hundred Fifty One Thousand Three Hundred Pesos Only (Php 251,600.00).
