Lease of Venue with Food and Accommodation for the conduct of Retooling Cum Seminar-Workshop on the Introduction to RA 12009 in preparation for the 2025 Government Procurement

WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue with Food and Accommodation for the conduct of Retooling Cum Seminar-Workshop on the Introduction to RA 12009 in preparation for the 2025 Government Procurement with an Approved Budget for the Contract (ABC) of One Hundred Eleven Thousand Three Hundred Pesos Only (Php 111,300.00).

WHEREAS, on Dec. 4, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) BORACAY TROPICS RESORT HOTEL; (2) REGENCY LAGOON RESORT INC.; (3) CASA PILAR DE BORACAY, INC.; (4) ALC HOTEL MANAGEMENT, INC.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Dec. 9, 2024, BORACAY TROPICS RESORT HOTEL, REGENCY LAGOON RESORT INC., CASA PILAR DE BORACAY, INC. and ALC HOTEL MANAGEMENT, INC. submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, CASA PILAR DE BORACAY, INC. is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
