

## BAC Resolution No. 0923 Series of 2024

**WHEREAS**, the Department of Agriculture has an original project, **Procurement of Supply and Delivery of Five (5) Units Corn Planter (IB 2024-107 AMV)** with an Approved Budget for the Contract (ABC) of **Five Million Pesos (Php 5,000,000.00)**;

**WHEREAS**, the Bids and Awards Committee (BAC) has issued a Resolution No. 2024- 000 dated September 19, 2024 recommending the award of Contract to AGRICOM VISAYAS INC. in the amount of Four Million Six Hundred Seventy-Five Thousand Pesos (Php 4,675,000.00);

**WHEREAS**, the BAC Resolution was approved by the Head of the Procuring Entity and a Notice to Proceed was issued and received by AGRICOM VISAYAS INC. on November 5, 2024;

**WHEREAS**, Five (5) Units were delivered on November 15, 2024;

**WHEREAS** the TWG likewise determined that the financial proposal submitted by AGRICOM VISAYAS INC. in the amount of **Four Million Six Hundred Seventy-Five Thousand Pesos Only (Php 4,675,000.00)** is the lowest quotation.

**WHEREAS**, a Purchase Request (PR) for the Procurement of Supply and Delivery of One (1) Corn Planter with an ABC of Nine Hundred Thirty-Five Thousand Pesos Only (Php 935,000.00) was made to utilize the savings out of Five Million Pesos (Php 5,000,000.00);

**WHEREAS**, under Section 51, Article XVI of R.A. 9184 and its Revised Implementing Rules and Regulations and when provided for in the Annual Procurement Plan, REPEAT ORDER as an alternative Method of Procurement may be allowed wherein the Procuring Entity directly procure GOODS from the previously contracted winning bidder under the following conditions;

- A. The unit price offered by AGRICOM VISAYAS INC. under Repeat Order is equal to or lower than that provided in the original contract;
- B. The repeat order does not result in splitting of requisitions or purchase orders;
- C. The repeat order is availed of within six (6) months from the date of the Notice to Proceed arising from the original contract wherein partial delivery, inspection and acceptance of the goods was already made; and
- D. The repeat order does not exceed twenty-five percent (25%) of the quantity of each item of the original contract.

**THEREFORE**, the BIDS AND AWARDS COMMITTEE, **RESOLVE** as it is hereby **RESOLVED** that **REPEAT ORDER** shall be the mode of procurement in favor of AGRICOM VISAYAS INC. for the Procurement of Supply and Delivery of One (1) Unit of Corn Planter in the amount of Nine Hundred Thirty-Five Thousand Pesos Only (Php 935,000.00);


