

**RESOLUTION NO. 279**  
**Series of 2024**  
(Resolution to Declare the Responsive Bidder)

**WHEREAS**, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Works for the Construction of YFC Business Development Center** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 2,000,000.00**;

**WHEREAS**, in response to the said advertisement, four (4) bidders submitted their application for eligibility and bid offer;

**WHEREAS**, the four bidders “passed” the preliminary examination of bid;

**WHEREAS**, the bid proposals of the four bidders were found to be substantially complying:

- b. To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.


