(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Rebid for the Procurement of Supply and Delivery of 743 bags Calcium Nitrate in Granular Form and 744 bags Complete Fertilizer in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 3,698,911.00;

WHEREAS, in response to the said advertisement, three (3) bidders submitted their application for eligibility and bid offer;

WHEREAS, the three (3) bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposal of the three (3) bidders were found to be substantially complying:

- To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings




