(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the Procurement of Supply and Delivery of Soil Ameliorant for 3,537 ha. in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 2,829,600.00;

WHEREAS, in response to the said advertisement, only lone bidder submitted its application for eligibility and bid offer;

WHEREAS, the lone bidder “passed” the preliminary examination of bid;

WHEREAS, the bid proposal of the lone bidder was found to be substantially complying;


