(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Rebid for the Procurement of Supply and Delivery of Drugs and Biologics in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of Php 4,372,500.00;

WHEREAS, with the foregoing evaluation results of the Technical Working Group, JTIM Enterprises was found to be the Single Calculated Bidder (SCB).


