RESOLUTION NO. 270

(Resolution to Declare the Responsive Bidder)

WHEREAS, the Department of Agriculture-Western Visayas advertised the Invitation to Bid for the **Procurement of Works for the Construction of 30 Sow Level Production Farm Facility Brgy. Agdayao, Passi, Iloilo (Lot 5) Brgy. Agdayao, Passi, Iloilo** in the DA-Western Visayas website, the PhilGEPS and a conspicuous place at the premises of DA-Western Visayas continuously for twenty-one (21) calendar days with an Approved Budget for the Contract (ABC) of **Php 5,953,978.35**;

WHEREAS, in response to the said advertisement, three (3) bidders submitted their application for eligibility and bid offer;

WHEREAS, the three (3) bidders "passed" the preliminary examination of bid;

WHEREAS, the bid proposals of three (3) bidders were found to be substantially complying:

WHEREAS, the detailed evaluation of the bids conducted on, October 2, 2024 resulted in the following:

NOE'S BUILDERS	Php 4,859,746.25	87.98 %
BABA BUILDERS OPC	Php 5,950,900.49	93.86 %

WHEREAS, with the foregoing evaluation results of the Technical Working Group, SCR CONSTRUCTION was found to be the Lowest Calculated Bidder (LCB).

WHEREAS, upon careful evaluation, validation and verification of all the eligibility, technical and financial requirements submitted by the Lowest Calculated Bidder (LCB), SCR CONSTRUCTION and Second Lowest Bidder, NOE'S BUILDERS failed to pass the post-qualification conducted by Technical Working Group (TWG) due to the ground that did not conform to the technical specifications as stated in the Philippine Bidding Documents. Therefore, SCR CONSTRUCTION and NOE's BUILDERS has found to be non-responsive.

WHEREAS, the same evaluation process was conducted to Third Lowest Calculated Bidder and upon careful evaluation, validation and verification of all the eligibility, technical and financial requirements submitted by the Third Lowest Calculated Bidder, BABA BUILDERS OPC has found to be responsive.

NOW, THEREFORE, WE, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;


- To declare BABA BUILDERS OPC as the bidder with the Third Lowest Calculated and Responsive Bid for the **Procurement of Works for the Construction of 30 Sow Level Production Farm Facility (Lot 5)**. in the amount of **Php 5,950,900.49**; and
- To recommend to the Head of the Procuring Entity the Award of the Contract based on the foregoing findings.
