

BAC Resolution No. 0041, Series of 2024

Procurement of Supply and Delivery of Office Equipment for Young Farmers Challenge (YFC) Business Development Center

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Office Equipment for Young Farmers Challenge (YFC) Business Development Center** with an Approved Budget for the Contract (ABC) of **One Hundred Thousand Pesos Only (Php 100,000.00)**.

WHEREAS, on Oct. 17, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **KNOA OFFICE SUPPLIES AND EQUIPMENT TRADING**; (2) **THREE N' ONE ENTERPRISES**; (3) **JUAN TONG & SONS BUILDER CORPORATION**; (4) **VMO AGRICULTURAL FARM SUPPLIES**; (5) **RESTU TRADING CORPORATION**

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Oct. 24, 2024, **KNOA OFFICE SUPPLIES AND EQUIPMENT TRADING, THREE N' ONE ENTERPRISES, JUAN TONG & SONS BUILDER CORPORATION, VMO AGRICULTURAL FARM SUPPLIES** and **RESTU TRADING CORPORATION** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **THREE N' ONE ENTERPRISES** and **JUAN TONG & SONS BUILDER CORPORATION** are both considered as the lowest offeror. However, **THREE N' ONE ENTERPRISES** did not submit omnibus sworn statement. Therefore, considered as non-responsive.

WHEREAS, **JUAN TONG & SONS BUILDER CORPORATION** is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **JUAN TONG & SONS BUILDER CORPORATION** in the amount of **Ninety Five Thousand Pesos Only (Php 95,000.00)** is the lowest responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Supply and Delivery of Office Equipment for Young Farmers Challenge (YFC) Business Development Center** to **JUAN TONG & SONS BUILDER CORPORATION** in the amount of **Ninety Five Thousand Pesos Only (Php 95,000.00)**.
