

BAC Resolution No. 001, Series of 2025**Procurement of Supply and Delivery of Monobloc Chair**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Supply and Delivery of Monobloc Chair** with an Approved Budget for the Contract (ABC) of **Seventy-Five Thousand Six Hundred Pesos Only (Php 75,600.00)**.

WHEREAS, on Oct. 18, 2024, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **ST. PHILOMENA MERCHANDISING**; (2) **OTING CONSTRUCTION AND SUPPLY**; (3) **CHE ENTERPRISES**; (4) **818 CONSTRUCTION**; (5) **THREE N' ONE ENTERPRISES**; (6) **JUANTONG AGRI-VENTURES, INC.**

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Oct. 25, 2024, **ST. PHILOMENA MERCHANDISING**, **OTING CONSTRUCTION AND SUPPLY**, **CHE ENTERPRISES**, **818 CONSTRUCTION**, **THREE N' ONE ENTERPRISES** and **JUANTONG AGRI-VENTURES, INC.** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ST. PHILOMENA MERCHANDISING** is considered as the lowest offeror. However, the supplier failed to comply the minimum requirements set by the agency. Therefore, considered as non-responsive.

WHEREAS, **OTING CONSTRUCTION AND SUPPLY** is considered as the 2nd lowest offeror. However, upon issuance of Notice of Award for the said procurement, the supplier sent a letter to cancel their bid. Therefore, the Bids and Awards Committee will move to the next responsive offeror.

WHEREAS, **CHE ENTERPRISES** and **818 CONSTRUCTION** is the 3rd and 4th lowest offerors. However, both suppliers also failed to comply the minimum requirements set by the agency. Therefore, considered as non-responsive.

WHEREAS, **THREE N' ONE ENTERPRISES** is considered as the lowest responsive offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2024 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS the TWG likewise determined that the financial proposal submitted by **THREE N' ONE ENTERPRISES** in the amount of **Seventy-Four Thousand Nine Hundred Twenty-Five Pesos Only (Php 74,925.00)** is the lowest responsive quotation.

WHEREAS the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and has been found to be compliant.

WHEREAS the report containing the results of the TWG evaluation is attached hereto as Annex "A," and made an integral part hereof.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, after duly considering the recommendations of the TWG, hereby resolve to recommend to the


