

BAC Resolution No. 0045, Series of 2025**Procurement of Vehicle Rental for the conduct of various activities of A Digital Platform for Data-Driven Decision Making in Support of the DA'S Fertilization Strategy through Cloud-Based and Monitoring of Rice Extension Interventions of the DA (DFARMS) Project for CY 2025**

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Vehicle Rental for the conduct of various activities of A Digital Platform for Data-Driven Decision Making in Support of the DA'S Fertilization Strategy through Cloud-Based and Monitoring of Rice Extension Interventions of the DA (DFARMS) Project for CY 2025 with an Approved Budget for the Contract (ABC) of One Hundred Pesos Only (Php 135,000.00).

WHEREAS, on Jan. 15, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) BENNCH TRANSPORT SERVICES; (2) RJ TRANSPORT SERVICES; (3) ISLAND ADVENTURE TOURS AND TRAVEL; (4) 7SQ OPC

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Jan. 22, 2025, BENNCH TRANSPORT SERVICES, RJ TRANSPORT SERVICES, ISLAND ADVENTURE TOURS AND TRAVEL and 7SQ OPC submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, RJ TRANSPORT SERVICES is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Vehicle Rental for the conduct of various activities of A Digital Platform for Data-Driven Decision Making in Support of the DA'S Fertilization Strategy through Cloud-Based and Monitoring of Rice Extension Interventions of the DA (DFARMS) Project for CY 2025 to RJ TRANSPORT SERVICES in the amount of Ninety Four Thousand Four Hundred Thirty Five Pesos Only (Php 94,435.00).
