

**BAC Resolution No. 0015, Series of 2025****Procurement of Food and Accommodation for the Training Workshop and Benchmarking on the Development of CBLP Enterprise for Ati Community-Lease of Venue (Lot 4)**

**WHEREAS**, the Department of Agriculture has a Purchase Request for the **Procurement of Food and Accommodation for the Training Workshop and Benchmarking on the Development of CBLP Enterprise for Ati Community-Lease of Venue (Lot 4)** with an Approved Budget for the Contract (ABC) of **One Hundred Sixty-Nine Thousand Fifty Pesos Only (Php 169,050.00)**.
