Provision for Vehicle Rental for various activities (Lot 7)

WHEREAS, the Department of Agriculture has a Purchase Request for the **Provision for Vehicle Rental for various activities (Lot 7)** with an Approved Budget for the Contract (ABC) of **Forty-Nine Thousand Five Hundred Pesos Only (Php 49,500.00)**.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Jan. 30, 2025, **BENNCH TRANSPORT SERVICES, RJ TRANSPORT SERVICES, ISLAND ADVENTURE TOURS & TRAVEL, 7SQ OPC and REYNSIE TRAVEL AND TOURS** submitted their quotations.

WHEREAS upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ISLAND ADVENTURE TOURS & TRAVEL** is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.


