Procurement of Vehicle Rental to be used for AMIA Activities

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Vehicle Rental to be used for AMIA Activities** with an Approved Budget for the Contract (ABC) of **Fifty-Eight Thousand Six Hundred Thirty-One Pesos Only (Php 58,631.00)** for lot 1 and **Nineteen Thousand Five Hundred Pesos Only (Php 19,500.00)** for lot 2 and **Thirty-Three Thousand Pesos Only (Php 33,000.00)** for lot 3.

WHEREAS, on Feb. 6, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **CBTMPC**; (2) **CHERALD TRAVEL & TOURS**; (3) **EXECUTIVE ELEGANCE CHARTERS, OPC**; (4) **RJB STAR TRANSPORT**; (5) **BENNCH TRANSPORT SERVICES**; (6) **ISLAND ADVENTURE TOURS AND TRAVEL**

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 10, 2025, **CBTMPC**, **CHERALD TRAVEL & TOURS**, **EXECUTIVE ELEGANCE CHARTERS, OPC**, **RJB STAR TRANSPORT**, **BENNCH TRANSPORT SERVICES** and **ISLAND ADVENTURE TOURS AND TRAVEL** submitted their quotations.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **BENNCH TRANSPORT SERVICES** is considered as the lowest offeror for lot 1, 2, and 3 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the **Procurement of Vehicle Rental to be used for AMIA Activities** to **BENNCH TRANSPORT SERVICES** in the amount of **Thirty Six Thousand Five Hundred Pesos Only (Php 36,500.00)** for lot 1 and **Fourteen Thousand Seven Hundred Pesos Only (Php 14,700.00)** for lot 2 and **Twenty One Thousand Pesos Only (Php 21,000.00)** for lot 3.


