WHEREAS, the Department of Agriculture has a Purchase Request for the Lease of Venue for Food and Accommodation of FY 2025- 1st Quarter DA-DPWH workshop and assessment meeting for the implementation of FMR projects on March 12-14, 2025 with an Approved Budget for the Contract (ABC) of One Hundred Ninety-Nine Thousand Six Hundred Seventy Pesos Only (Php 199,670.00).

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, ALOBIOD COVE RESORT is considered as the lowest offeror and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.
