

BAC Resolution No. 012, Series of 2025

Procurement of Food Services for the Conduct of Provincial Agricultural Stakeholders Forum in the Province of Aklan, Antique, Capiz, Guimaras & Iloilo

WHEREAS, the Department of Agriculture has a Purchase Request for the Procurement of Food Services for the Conduct of Provincial Agricultural Stakeholders Forum in the Province of Aklan, Antique, Capiz, Guimaras & Iloilo with an Approved Budget for the Contract (ABC) of One Hundred Two Thousand Six Hundred Pesos Only (Php 102,600.00) for lot 1 and One Hundred Twenty Eight Thousand Pesos Only (Php 128,000.00) for lot 2 and One Hundred Twenty Eight Thousand Pesos Only (Php 128,000.00) for lot 3 and Sixty Eight Thousand Four Hundred Pesos Only (Php 68,400.00) for lot 4 and Two Hundred Sixteen Thousand Pesos Only (Php 216,000.00) for lot 5.

WHEREAS, on Feb. 7, 2025, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to the following prospective suppliers, viz: (1) **ORO LUCKY CATERING SERVICES**; (2) **ATI-ATIHAN FESTIVAL HOTEL CORPORATION**; (3) **ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE** for lot 1 and (1) **JJ SEAFOODS & RESTAURANT**; (2) **EDEN RESORT HOTEL**; (3) **PARVANA INN & SUITES** for lot 2 and (1) **MARIBERT INLAND RESORT**; (2) **VINCENT CATERING SERVICES**; (3) **VILLA CONSORCIA RESORT & RESTAURANT** for lot 3 and (1) **NUEVA VALENCIA MULTI-PURPOSE COOPERATIVE**; (2) **RAYMEN BEACH RESORT CORP.**; (3) **ALOBIJOD COVE RESORT** for lot 4 and (1) **ILOILO GRAND HOTEL**; (2) **J&P CANTINA, INC.**; (3) **3L PROPERTIES & ALPHA DEV'T CORP. (GOLDBERRY LITE HOTEL)** for lot 5.

WHEREAS, before the lapse of the deadline for submission of quotation at 5:00 PM. on Feb. 12, 2025, **ORO LUCKY CATERING SERVICES**, **ATI-ATIHAN FESTIVAL HOTEL CORPORATION** and **ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE** submitted their quotations for lot 1 and **JJ SEAFOODS & RESTAURANT**, **EDEN RESORT HOTEL**, **PARVANA INN & SUITES** submitted their quotations for lot 2 and **MARIBERT INLAND RESORT**, **VINCENT CATERING SERVICES**, **VILLA CONSORCIA RESORT & RESTAURANT** submitted their quotations for lot 3 and **NUEVA VALENCIA MULTI-PURPOSE COOPERATIVE**, **RAYMEN BEACH RESORT CORP.**, **ALOBIJOD COVE RESORT** submitted their quotations for lot 4 and **ILOILO GRAND HOTEL**, **J&P CANTINA, INC.**, **3L PROPERTIES & ALPHA DEV'T CORP. (GOLDBERRY LITE HOTEL)** submitted their quotations for lot 5.

WHEREAS, upon careful evaluation, validation, and verification of all the documentary requirements and specification stated in the Request for Quotation, **ATI-ATIHAN FESTIVAL HOTEL CORPORATION** is considered as the lowest offeror for lot 1. However, the supplier did not submit any documentary requirements. Therefore, considered as non-responsive.

WHEREAS, **ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE** is considered as the lowest responsive offeror for lot 1 and with price quotation within the ABC and it was found to be compliant with the eligibility requirements as evidenced by the submission of its 2025 Mayor's/Business Permit and provision of PhilGEPS Registration Number.

WHEREAS, PARVANA INN & SUITES is considered as the lowest offeror for lot 2 and VILLA CONSORCIA RESORT & RESTAURANT for lot 3 and NUEVA VALENCIA MULTI-PURPOSE COOPERATIVE for lot 4 and J&P CANTINA, INC. for lot 5.

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE, hereby resolve to recommend to the HOPE, for his consideration and approval, the award of contract for the Procurement of Food Services for the Conduct of Provincial Agricultural Stakeholders Forum in the Province of Aklan, Antique, Capiz, Guimaras & Iloilo to ATI-RTC VI EMPLOYEES MULTI-PURPOSE COOPERATIVE in the amount of One Hundred Thousand Eight Hundred Pesos Only (Php 100,800.00) for lot 1 and to PARVANA INN & SUITES in the amount of One Hundred Twenty Three Thousand Pesos Only (Php 123,000.00) for lot 2 and to VILLA CONSORCIA RESORT & RESTAURANT in the amount of One Hundred Twenty Seven Thousand Pesos Only (Php 127,000.00) for lot 3 and to NUEVA VALENCIA MULTI-PURPOSE COOPERATIVE in the amount of Sixty Seven Thousand Eight Hundred Pesos Only (Php 67,800.00) for lot 4 and to J&P CANTINA, INC. in the amount of One Hundred Eighty One Thousand One Hundred Twenty Pesos Only (Php 181,120.00) for lot 5.
